
Offering free and reliable legal information online since 2002.

Founded in 1977, Texas Legal Services Center (TLSC) is a nonprofit organization that provides legal advice, advocacy, representation, and education to underserved people across the state. With more than a dozen practice areas, our work touches almost every aspect of civil law that impacts low-income Texans.

TexasLawHelp.org began in 2002 and is part of a greater TLSC effort to empower self-represented litigants. For Texans who must represent themselves in the justice system, we offer advice, court-approved legal forms, and instruction on how to achieve the most desirable outcome.



By successfully addressing simple civil legal issues, we ensure that families have safe and secure homes, access to basic necessities, and increased financial security. Sponsorship of TexasLawHelp.org enhances and expands TLSC's delivery of these critical legal services.



All content on TexasLawHelp.org is free and available for the public to use. The website houses DIY legal guides, pro-se forms, and directories for free legal aid clinics and organizations.
